### 1. What are the criteria for the QLDS Special Bursary Awards?

Tenure	For 2 years, subject to satisfactory review and renewal.

### 2. When should I submit my application form?

Please submit your application form as soon as possible to TIS Admissions (either TIS Kuala Lumpur or TIS Puchong), as the Special Bursary Awards are limited and subject to availability.

### 3. How do I apply and what documents are required?

To apply, students need to complete the application form. The form (soft copy) may be obtained from TIS website: [www.tis.edu.my](http://www.tis.edu.my).

Applicants are required to submit the following:

- (i) Completed application form
- (ii) School recent reports and certificates

#### **4. How do I know if I am shortlisted for the Special Bursary Awards interview and assessment?**

Shortlisted candidates will be notified on an interview and an assessment by our Admissions Team. During the MCO period, it'll be done online but once MCO is lifted, the interview and assessment will take place in the school. Our Admissions Team will be in touch on the arrangement details.

#### **5. Who will be interviewing me?**

The Special Bursary Awards Panel consisting of the Principal and Head of Secondary of the respective TIS campuses shall conduct the interview.

#### **6. What happens if I am sick or absent on the day of the assessment or interview?**

You can reschedule the assessment or interview by providing a medical certificate, by contacting the Admissions Team.

#### **7. How can I prepare for the interview and assessment?**

The interview will be an opportunity for the Special Bursary Awards Panel to get to know the student better. Applicants should be confident to share and express themselves with the panel members, and share their achievements.

The student need not study any particular subject, just to come prepared as they are. The Assessment is based on the student's reasoning ability, verbal and non-verbal skills. This helps the school to assess the level of each student's capability.

#### **8. How long will the school take to evaluate the Bursary application?**

The evaluation shall take no longer than two weeks, even during the MCO period or any extension.

#### **9. If I accept the offer of the Special Bursary Award, can I change my mind later?**

Yes, you can decline the Bursary Award (within a week from the receipt of the Offer Letter). However, once declined the Bursary Award will not be offered again. Once the candidate has decided to accept the offer, he/she must within a week notify the Admissions Department to register with the School.

#### **10. Are there any academic or behavioural expectations attached to the Bursary Award?**

The Bursary Award may be revoked if there are serious disciplinary offences within the 2 years of the award period. However, this would be after careful consideration and dialogue between the School and the student.

It is mandatory for the Bursary Award holders to consistently maintain good academic standards, as well as participate actively in the school's sports and co-curricular activities (CCAs).

The Bursary Award holder is required to diligently attend all classes as required by the School, unless he/she is unable to do so due to illness, in which case a medical certificate must be produced.

The Bursary Award holder is required to demonstrate exemplary behaviour and to comply with all the School's rules and regulations at all times. The Bursary Award holder is prohibited from engaging in any activity that may adversely affect the school's reputation.

### **13. Can the Bursary Award be deferred to another term?**

This is not possible. The Bursary Award is only open for the 2020 intake (Term 3) and 2021 intake (Term 1).

### **14. Can the Bursary Award be transferred to another TIS campus?**

Yes, subject to availability of place at the other TIS campus. This Special Bursary Awards is open to both TIS Kuala Lumpur and TIS Puchong.
