

# Taylor's IGCSE Scholarships 2026 (External)

## 1. What are the criteria for Taylor's IGCSE Scholarships 2026?

Eligibility	Open to Malaysian students only. To qualify, applicants must be of the following age in the year of intake:    Age

# 2. When should I submit my application form?

All application forms must be submitted to the respective campuses (TIS Kuala Lumpur or TIS Puchong) by **30**<sup>th</sup> **September 2025 (Tuesday).** 

## 3. How do I apply, and what documents are required?

To apply, simply complete the online aplication available on our website.

Be sure to prepare the required supporting documents in soft copy for attachment.

- (i) A copy of the student's MyKad
- (ii) Student's photograph
- (iii) Latest academic results
- (iv) Relevant certificates or awards (if any)

### 4. How do I know if I am shortlisted for the Scholarships assessment and interview?

Shortlisted candidates will be notified by phone to attend an assessment, followed by an interview. Our Admissions Team will be in touch with the arrangement details.

## 5. Who will be interviewing me?

The interview will be conducted by the Scholarship Panel at the respective TIS campuses, comprising the Principal, Head of Secondary, and a member of the Senior Management team.

#### 6. What happens if I am sick or absent on the day of the assessment or interview?

To reschedule the assessment or interview, please contact the Admissions Team and provide a medical certificate.

### 7. How can I prepare for the interview and assessment?

The interview offers an opportunity for the Scholarship Panel to get to know the student better. Applicants are encouraged to express themselves confidently, share their interests, experiences and highlight any notable achievements.

There is no need to study any specific subject in advance. Students should simply come as they are, prepared to engage thoughtfully. The assessment will focus on reasoning ability, as well as verbal and non-verbal skills, allowing the school to understand each student's strengths and potential.

## 8. How long will the school take to evaluate the Scholarship application?

Candidates will be notified of the outcome of the interview within 2 weeks by phone.

#### 9. If I accept the offer of the Scholarship, can I change my mind later?

Yes, you may decline the Scholarship within one week of receiving the Offer Letter. However, please note that once declined, the Scholarship offer will not be extended again.

If the candidate chooses to accept the offer, they must notify the Admissions Department within one week to proceed with registration at the school.

#### 10. Are there any academic or behavioural expectations attached to the Scholarship?

The Scholarship may be revoked in the event of serious disciplinary offences during the two-year award period. Any such decision will only be made following careful consideration and dialogue between the School and the student.

Scholarship recipients are expected to:

- Maintain strong academic performance throughout the duration of the programme.
- Participate actively in the School's sports and co-curricular activities.
- Attend all classes diligently, unless excused due to illness, in which case a valid medical certificate must be provided.
- Exemplify outstanding behaviour and uphold the School's rules and regulations at all times.

The Scholarship holder is required to demonstrate exemplary behaviour and to comply with all the School's rules and regulations at all times. The Scholarship holder is prohibited from engaging in any activity that may adversely affect the school's reputation.
